Privacy Policy

PreciseTarget, Inc. ("PreciseTarget," "we," "our," "us" or "company") has the highest respect for your privacy and personal information. This Privacy Policy describes PreciseTarget's handling of your personal information it may collect (a) through your use of this website or any of the products or services available through this website (the "Site"), or (b) from any third-party vendors in connection with any products, services, or contests or promotions provided by or on behalf of PreciseTarget, or which are sponsored by PreciseTarget (together with the Site, the "PreciseTarget Offerings").

INFORMATION WE COLLECT

We gather information about how visitors use our Site, as well as information from interested or current customers.

The following are the types of information we collect:

- Information you give us: We receive the information you provide to us when you register for, or otherwise use, the Site such as your name, email address, business name, title, business URL, business industry, business type, phone number, address, credit card information and any feedback, questions, or recommendations you provide. If you provide information directly to us in other ways, such as by sending us an email or filling out a form, we may retain that information and add it with the other information we have collected from you. We may also collect information from you that is necessary for our legitimate interests, which will be disclosed to you at the time of collection. PreciseTarget will use this information for the purposes of which it was collected.
- Information from third parties: We may receive information about you from other sources, such as from referrals, third-party sites or data services, or otherwise. We may add this information to the information we have already collected from you.
- Automatically collected information: To make our Site and Services more useful to you, our servers (which may be hosted by a third-party service provider) may collect information from you, including browser type, operating system, Internet Protocol (IP) address (a number that is automatically assigned to your computer when you use the Internet, which may vary from session to session), domain name, precise location data with GPS or lat/log, or a date and time stamp for your visit. We also use Cookies (as defined below) and navigational data to gather information regarding the date and time of your visit and the solutions and information for which you searched and which you viewed. Like most Internet services, we automatically gather this information and store it in log files each time you visit our Site or access your account on our network. We also

could use data from mobile applications, including advertising IDs and mobile device IDs, to gather information regarding the date and time of your visit and the solutions and information for which you searched and which you viewed. Mobile advertising IDs or Mobile Device IDs are a unique identifier which can be used to identify a mobile device. Mobile applications and networks assign unique identifiers for mobile app developers can identify who is using their mobile apps as well as for advertising purposes.

HOW WE USE COLLECTED INFORMATION

By registering for our products and services, or engaging with our brand, you provide us consent to collect and use your personal information for the following purposes:

- To operate and improve our Sites
- To fulfill your requests for certain products or services
- To provide you with content and information relevant to your interests in our product and services to facilitate and enhance your use of the platform
- To better understand your needs and provide you with more customized service
- To communicate with you about the Sites or our products and services
- To respond to any questions or concerns that you may have

We may create anonymous or aggregate data from the information we collect. We may use that data for our own purposes or disclose it to third parties at our own discretion.

INFORMATION SHARING

We may share collected information under the following situations;

- To suppliers, service providers or contractors that provide services to us and are contractually bound to safeguard your personal information. These services include messaging services, credit card processors, website hosting and analytics. These recipients are required by contract to keep confidential the information received on our behalf, and may not use it for any purpose other than to carry out the services they are performing for us
- With advertising services to assist PreciseTarget with our own corporate marketing efforts
- To third parties in connection with any merger, acquisition, reorganization, change in capital structure or sale of all or substantially all of the assets of PreciseTarget
- When we have a good faith belief that disclosure is necessary to comply with the law, protect or defend our rights or the rights of other users of our Sites or products or services, or act in an emergency to protect someone's safety, or

• Otherwise with your express consent.

- Location information, which is attached to a pseudonymized identity, such as zip code or the approximate geographic area derived from your IP address or location positioning information provided by the location services and GPS features of your mobile device when location services have been enabled
- Pseudonymous matched or linked data that enables our clients to match identities across channels. The matched or linked data comes from third party data providers, brands, and websites with the rights to share and match consumer data for marketing purposes. We combine and measure these data sets against each other to ensure a high level of accuracy.

Please note that we license PreciseTarget data in pseudonymized or encrypted form to third parties such as website publishers, advertising agencies and marketers. A third-party licensee using PreciseTarget may elect to collect, manage, and use other types of data through PreciseTarget, which may include personal information associated with the pseudonymized or encrypted ids (where permissible). - **Opt-out of sales.** All data that powers our model is acquired via opt-in at the time that we receive it. Should you believe your personal information has contributed to our models in error or should you want to opt-out of inclusion in future model creation, you

may do so through an opt-out request through our identity management partner, Neustar <u>here</u>
